### SECTION 4: First aid measures

#### 4.1. Description of first aid measures

<b>General information</b>	Not considered to be a significant hazard due to the small quantities used. Get medical attention immediately. Show this Safety Data Sheet to the medical personnel.
<b>Inhalation</b>	Remove affected person from source of contamination. Move affected person to fresh air and keep warm and at rest in a position comfortable for breathing. Maintain an open airway. Loosen tight clothing such as collar, tie or belt. When breathing is difficult, properly trained personnel may assist affected person by administering oxygen. Place unconscious person on their side in the recovery position and ensure breathing can take place.
<b>Ingestion</b>	Rinse mouth thoroughly with water. Remove any dentures. Give a few small glasses of water or milk to drink. Stop if the affected person feels sick as vomiting may be dangerous. Do not induce vomiting unless under the direction of medical personnel. If vomiting occurs, the head should be kept low so that vomit does not enter the lungs. Never give anything by mouth to an unconscious person. Move affected person to fresh air and keep warm and at rest in a position comfortable for breathing. ## **SECTION 5: Firefighting measures**

### **5.1. Extinguishing media**

**Suitable extinguishing media**      The product is flammable. Extinguish with alcohol-resistant foam, carbon dioxide, dry powder or water fog. Use fire-extinguishing media suitable for the surrounding fire.

### **5.2. Special hazards arising from the substance or mixture**

**Specific hazards**                      Containers can burst violently or explode when heated, due to excessive pressure build-up. If aerosol cans are ruptured, care should be taken due to the rapid escape of the pressurised contents and propellant. Not considered to be a significant hazard due to the small quantities used.

**Hazardous combustion products**      Thermal decomposition or combustion products may include the following substances: Harmful gases or vapours.

### **5.3. Advice for firefighters**

**Protective actions during firefighting**      Avoid breathing fire gases or vapours. Evacuate area. ## SECTION 7: Handling and storage

### 7.1. Precautions for safe handling

**Usage precautions** Read and follow manufacturer's recommendations. Wear protective clothing as described in Section 8 of this safety data sheet. Keep away from food, drink and animal feeding stuffs. Avoid exposing aerosol containers to high temperatures or direct sunlight. The product is flammable. Keep away from heat, hot surfaces, sparks, open flames and other ignition sources. No smoking. Avoid discharge to the aquatic environment. Do not handle until all safety precautions have been read and understood. Do not handle broken packages without protective equipment. Do not reuse empty containers. ### Appropriate engineering controls

Provide adequate ventilation. Personal, workplace environment or biological monitoring may be required to determine the effectiveness of the ventilation or other control measures and/or the necessity to use respiratory protective equipment. Use process enclosures, local exhaust ventilation or other engineering controls as the primary means to minimise worker exposure. Personal protective equipment should only be used if worker exposure cannot be controlled adequately by the engineering control measures.
